MESSAGE FROM THE EXECUTIVE DIRECTOR AND BOARD PRESIDENT

Dear Neighbors,

In 2021 Island Housing Trust laid the foundations for a strong future for Mount Desert Island's communities. This annual report is a bit different; it provides the traditional brief synopsis

of the work accomplished in 2021 and of our financial position, and it provides a report on our *Coming Home Campaign for Mount Desert Island.*

In 2021, IHT completed local and state permitting for the new Jones Marsh neighborhood

at the head of the island. At this writing, six of those ten homes are in place and we are working to get the families in by year-end 2022.

Our Home Ownership Assistance Program (HOAP) provided funding to a beloved local school teacher, enabling her to purchase her first home. The house was placed on its foundation in December, and completed this year for move in. HOAP also enabled IHT to work with homeowners who wanted to sell their house to their long-term renters. Two goals were achieved: a household currently living and working on MDI were able to remain in their home, and another year-round house is under

> covenant to ensure its affordability into the future.



Ted Koffman: IHT Advocate



Ted Koffman's latest and biggest passion is reading to his grandchildren.

TED KOFFMAN is passionate.

He's been a passionate advocate for the environment, as a legislator and head of Maine Audubon. He's passionate about canoeing, spending days on the Allagash. He's passionate about his friends and family, and about living on MDI. And he is definitely passionate about the housing issues affecting our island community.

Back at the beginning of the new century, Ted was involved with MDI Tomorrow, a citizens group looking at the future of MDI. His involvement in the group led to new knowledge of the effects of the lack of housing for year-round working families on the island. As he traveled to Augusta

for legislative sessions, he saw lines of cars heading to MDI early every morning and realized these were workers who could not afford to own a house on MDI so commuted each day, some from as far away as Bangor.

When Island Housing Trust was revitalized and restructured from the Mount Desert Community Trust in 2003, Ted was a vital part of its new incarnation. His passion for housing issues led him to several stints on the board of the organization and to two terms as president, where he helped lead the creation of Ripples Hill, IHT's first workforce housing neighborhood.

Ted plans to step off the board in 2022, but his passions remain. "It's great to conserve natural resources, but equally important to conserve MDI's communities. It's been an honor and a pleasure to work with Island Housing Trust, and I know that it's in good hands for the future."

PROPERTIES IN MOTION



SOLD IN 2021 Wildwood Road, Seal Harbor

In 2020, IHT partnered with the Acadia Corporation to acquire a house sitting on a quiet, sunny corner lot in Seal Harbor Village. IHT sold the house to a local realtor for her own use in early 2021.

David Woodside, president and CEO of Acadia Corporation, noted that the home served as housing for valuable employees for many years. The Acadia Corporation has always believed in and supported the year-round community on MDI and believes that IHT's work provides a valuable contribution to supporting year-round housing opportunities to residents who serve our island communities.

The house has four bedrooms, one bathroom, and a full basement. IHT staff and board members worked together to repaint and refresh the interior and spruce up the exterior. IHT purchased the house from Acadia Corporation to resell it to eligible applicants, with covenants that will keep it affordable for year-round workers into the future.



SOLD IN 2021 Lookout Way, Northeast Harbor

In late 2020, Island Housing Trust partnered with Mount Desert 365 to ensure a home in Northeast Harbor remained available to yearround households using a shared equity model and affordability covenants. Today, it is the home of a family with deep ties to MDI who purchased it in early 2021.

The home's owners were committed to seeing their house remain a year-round home. As multi-generation Northeast Harbor residents, they have seen their children play in the same fields as their parents and grandparents. They wanted to see the lights stay on year-round on the house on Lookout Way. IHT facilitated MD365's sale of the house to a local family and manages the covenants that will keep it affordable.








STEP BY STEP

The Jones Marsh neighborhood is becoming a reality. In 2018, IHT purchased the land in partnership with Maine Coast Heritage Trust, with plans to develop it into a new year-round workforce neighborhood. IHT kicked off a capital campaign in 2020 to raise \$3.5 million, with \$2 million earmarked for Jones Marsh.

In 2021, with the successful completion of the campaign,

work started at Jones Marsh. All permits were granted. The land was selectively cleared for a road and house lots. Infrastructure was put into place, including foundations and septic systems. In summer 2022, the first houses arrived and were installed. As the homes are finished, new year-round residents will move in, creating the Jones Marsh neighborhood.





CAMPAIGN SUCCESS

We started quietly in the summer of 2020 but we ended with a bang on December 31, 2021!

Thank you to everyone who recognized the critical need for workforce housing on MDI and stepped forward to support *Coming Home: IHT's Campaign for Mount Desert Island*. Your vision and generosity are creating new housing opportunities on MDI.

Our goals were simple: raise \$3.5 million to build Jones Marsh, our new workforce neighborhood at the head of the island, expand our Home Owners Assistance Program, and create an Opportunities Fund to explore new housing opportunities. GOALS ACHIEVED!

The goal of IHT's *Coming Home Campaign for MDI* was to raise \$3.5 million to build new homes, assist people in buying existing island homes, and create an Opportunities Fund.

With the support of individuals and businesses, we have exceeded our goal, raising over \$3.66 million!

Goal 1: Complete the Jones Marsh Project.

In 2018, through a partnership project with Maine Coast Heritage Trust, IHT purchased 30 acres in Bar Harbor. IHT is now developing the land into a neighborhood of ten affordable and energy-efficient homes.

The subdivision received

all its permits and ground construction began in early 2022. Infrastructure work included road construction into the neighborhood, followed by preparation of the house sites. IHT contracted for the construction and placement of four single-family houses and one duplex in 2022. The remaining units are planned for 2023. IHT has approved applicants for the purchase of the first six homes, which were delivered and placed at the end of July by Showcase Homes in Brewer.

Goal 2: Scale up our Home Ownership Assistance Program (HOAP).

Sometimes the only stumbling block for someone purchasing an



otherwise affordable home is the down payment. HOAP can provide the funds to bridge that gap. The average HOAP project is \$25,000. Buyers who accept this assistance agree to covenants being placed on their property. This is an efficient way to ensure the home will remain an affordable, year-round residence in perpetuity. in 2021. A modular home was delivered to a site in Bar Harbor in December 2021 to become a yearround home for a local teacher. Another home in Mount Desert was purchased by IHT from the owners who wanted it to go remain a yearround home. IHT then sold the house with covenants to a family committed to staying on MDI.

Goal 3: Create an Opportunities Fund.

The Opportunities Fund will enable IHT to act quickly when affordable homes come up for sale. We will invest in the houses and resell them at an affordable price with covenants to ensure they remain affordable to year-round buyers in the future. The Opportunities Fund will also allow us to secure land for additional projects.

IHT has several projects under consideration, including property in Southwest Harbor, a 55-acre parcel in Town Hill in partnership with Acadia National Park and the Town of Bar Harbor, and others across MDI. All offer great opportunities to increase the stock of houses affordable to those earning a median income on MDI.

IHT funded two HOAP projects

A MATCHING OPPORTUNITY

As the *Coming Home* campaign was heading toward the last few months of 2021, IHT received word that an anonymous donor was issuing a challenge grant that would match dollar-fordollar all donations received through the end of the year.


IHT made the announcement public in November 2021, and donors responded. By December 31, 2021, over 100 donors – individuals, businesses, and foundations – had donated more than \$450,000 to bring the campaign to a successful close. All funds raised through the challenge will be used to support the completion of the ten-home Jones Marsh neighborhood and other IHT priorities.

"This was an incredible opportunity for IHT. This grant and the gifts raised to meet the challenge have enabled us to exceed our goals, so we can do even more to provide yearround housing on MDI. We are extremely grateful to this generous donor for investing in our work in a way that inspired others to deepen their support," said Marla O'Byrne, IHT's executive director.

As part of IHT's outreach efforts for the *Coming Home* campaign, we reached across the island, sending an appeal for support to over 5,000 addresses on MDI. The message, highlighting the difficulties of finding homes on MDI and its impact on families, resonated. IHT received over \$20,000 from a broad base of community support, including over 40 donors who were brand new to IHT. These gifts help the people of MDI, people who are the workers, the public servants, the helpers, the teachers – those who are the backbone of a vibrant community.
