

#### Individuals can make a difference!

In early 2017, Alan and Amanda Mogridge, who had moved to Mount Desert Island in 2014, thought things were going well. Alan was recovering from a medical issue, they had welcomed their first child, and had found a wonderful rental house in Trenton after moving from an apartment on MDI. That changed when they received notice from their landlord that they would need to vacate their home in 45 days. Alan, a dedicated optimist, told Amanda that he just knew that although the journey wouldn't be easy, things would get better.

Knowing that prospects were dismal for finding a house for rent on MDI or in nearby towns, Alan reached out on Facebook to ask for help. Rob and Cristy Benson, friends of Alan and Amanda, responded, saying they were building a new house in Bar Harbor and they would be happy to rent their current house in Mount Desert to them. And by May of 2017, the Mogridges had moved into what they describe as a "beyond perfect house in an amazing place."

Rob and Cristy knew that their beloved home of 14 years, where they had raised their two sons, would be well cared for by Alan and Amanda. It was important to them that their house would be home to a year-round family who worked on MDI and had community connections. The Mogridges were the perfect fit. They rented the house through 2021, and welcomed another child to their family.

In 2021, the Bensons were ready to sell the house. They didn't want to

see it become a seasonal or weekly rental, taking another year-round house out of circulation. They wanted to ensure a year-round family would be the new owners. Rob approached Alan with the idea of him and Amanda buying the home they'd lived in for almost five years, and obviously loved. It seemed like an impossible dream, knowing that house prices had spiked during the pandemic. But the Bensons were willing to explore options that would make home ownership possible for the Mogridges.

Both Rob and Cristy were familiar with Island Housing Trust, with friends living in IHT neighborhoods, so they approached the organization to ask if there was any way they could create a new housing opportunity with their house in

Mount Desert. Alan and Amanda applied and were approved by IHT to become homeowners of a house with year-round, affordability covenants. After several meetings and consultations with IHT's Board of Directors, a solution was found.

This January, IHT purchased the house from the Bensons,

and after placing affordability covenants on the house, IHT sold it to the Mogridges at a lower price, with a 99-year land-lease. With this model, IHT retains ownership of the land and the Mogridges own the buildings, keeping the house affordable and ensuring that it remains a yearround home that is affordable to median-income workers in the future. Rob and Cristy were delighted to have the Mogridges remain in the home, and the Mogridges were happy knowing that when they were ready to move on, the house would become available for the next year-round family.

As Alan said, things would get better. In fact, things couldn't be more perfect.

#### NEW OPPORTUNITIES

Chris's Pond, Southwest Harbor

Over the years Island Housing Trust has had the good fortune to partner with Maine Coast Heritage to advance conservation and year-round community. Recently, MCHT has been working with Southwest Harbor's Conservation Commission to expand the town's beloved Chris's Pond area. Chris's Pond, a pocket park which for decades has provided a quiet woodland skating pond, was protected by the town and MCHT in the mid-1990s. Recently MCHT had the opportunity to purchase an abutting property to expand protection around the pond and provide dedicated parking. The abutting property also has sufficient space to create new yearround workforce housing; MCHT has been working with IHT to explore that possibility. This is one of those rare projects that aligns multiple partners to benefit our year-round community.

We have heard strong support from the community for these new housing and conservation opportunities in Southwest Harbor, and look forward to partnering to pursue them.

IHT's newest neighborhood at Jones Marsh is underway. You'll find details and photos elsewhere in this newsletter. This progress has been made possible thanks to the generosity of our community when we asked for your support, you responded! From September 2020 to December 2021, nearly 300 generous supporters gave more than \$3.5 million to Coming Home: IHT's Campaign for MDI to create new year-round housing opportunities for the island's workforce.

In late 2021 an anonymous donor offered a challenge grant to match up to \$400,000 in gifts and pledges. It was just the incentive needed to inspire more than 100 donors to meet the challenge in just two months. With the end of the year push, IHT blasted past the challenge, exceeding it and our campaign goal.

There are so many people for us to thank, which we will do in an annual and campaign report this summer. For now, I am pleased to note that we received donations of all sizes from individuals, businesses, and foundations. A public campaign

across MDI brought in dozens of new supporters. All of us at IHT sav "THANK YOU" to everyone who contributed!

We talked with you at the local libraries over Zoom, presented to Rotary and Chambers, and heard from many of you with questions and ideas. # **EXCITING HAPPENINGS AT JONES MARSH**

Jones Marsh is closer to becoming IHT's newest neighborhood!

The subdivision has received all its permits and ground construction has begun. Infrastructure work has started with road construction into the neighborhood, to be followed by preparation of the house sites.

IHT has contracted for the construction and placement of four single-family houses and one duplex in 2022. The remaining

units are planned for 2023. IHT has approved applicants for the purchase of the first six homes, which are scheduled to be delivered late this summer.
